Scrutinizer's Report on Postal Ballot and e-voting conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 ("the Act") and Rule 22 of the Companies (Management and Administration) Rules, 2014 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, and SEBI (LODR) Regulations, 2015.

- I, B. L. Khandelwal, Practicing Chartered Accountant having its office at 1, Doctor's Lane, Gole Market, New Delhi 110001, have been appointed as a Scrutinizer of ECE Industries Ltd. ("the Company") pursuant to section 110 of the Companies Act, 2013 and Rule 22 of the Companies (Management and Administration) Rules, 2014 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended upto date and SEBI (LODR) Regulations, 2015, for the purpose of Scrutinizing the e-voting and Postal Ballot process in a fair and transparent manner and ascertaining the requisite majority on e-voting and Postal Ballot carried out as per the provision of Companies Act, 2013 on the below mentioned resolution. We submit our report as under:
- 1. The e-voting period remained open from 20.02.2019 (09:30 a.m.) to 21.03.2019 (5.00 p.m.).
- 2. The physical postal ballots received only upto 05:00 p.m. on 21.03.2019 through self-addressed business reply envelopes or otherwise, have been considered for voting.
- 3. The votes were unblocked on 22.03.2019 for e-voting and postal ballot (physical voting) in the presence of two witnesses who are not in the employment of the Company. They have appended their signature in Confirmation of the votes being unblocked in their presence.

- 4. Thereafter, the details, containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website of National Securities Depository Limited.
- 5. The shareholders holding shares as on the "cut off" date i.e. 8th February, 2019 were entitled to vote on the proposed resolutions (Item no.1 as set out in the Notice of Postal ballot dated 9th February, 2019).
- 6. The results of the e-voting/Postal ballot are as under:
